

Finance Manager's Report 1 April 2018 to 31 March 2019

1.0 Introduction

- 1.1 World Heritage UK is a Charitable Incorporated Organisation (CIO) and was registered with the Charity Commission (charity number 1163364) on 1 September 2015.
- 1.2 This report details the Income and Expenditure Account from 1 April 2018 to 31 March 2019.
- 1.3 An Independent Examiner's report has been carried out by Andrew Chappell FCA MIMgt of Chappell Associates Ltd as required by the Charity Commission for those charities with gross incomes greater than £25,000 per annum.
- 2.0 Income and Expenditure Account from 1 April 2018 31 March 2019 (Appendix 1)

Income

- 2.1 Income received between 1 April 2018 and 31 March 2019 was £106,032. This was made up of membership subscriptions (£24,608), income from meetings (£4,684) and the annual conference (£18,523) in the prestigious Tower of London.
- 2.2 World Heritage UK received its first payment for the *Unlocking the Potential* Resilient Heritage Project from the National Lottery Heritage Fund for work planned for 2019-20. This money is ring-fenced for project activity and currently held on deposit.
- 2.3 World Heritage UK received a total of £2,000 in meeting sponsorship from Lichfields UK Ltd and Border Archaeology.
- 2.4 World Heritage UK received support towards the World Heritage UK Review which is due in 2019 from Historic England, the National Trust and the National Lottery Heritage Fund. We are very grateful to all our public and private sector supporters which enables us to carry out our work.
- 2.5 The continuing increase in individual members is welcome with an increase from 41 in 2017-18 to 52 in 2018-19.
- 2.6 The Board is grateful for the in-kind support of Fieldfisher for use of their meeting rooms for Trustees' meetings in London during 2018-19. From April 2019 Trustees meetings are being held in the offices of Arup Ltd in London.
- 2.7 Two changes in financial policy were made for 2018-19 to improve the two of the three main income streams available to World Heritage UK. The first was to increase the voting membership fee for 2018/19 to £600. The other was to reduce discounts to members for

meetings as World Heritage UK could not afford to subsidise these events. The events are now priced so that they provide a contribution to annual overheads. Both initiatives have helped improve the sustainability of World Heritage UK. The third income stream is financial support from the public and private sector. This is an area that still needs to be developed and it is intended that the ongoing *Unlocking the Potential* Resilient Heritage Project which is being generously supported by the National Lottery Heritage Fund will explore this area of funding further. The fruits of this work will be seen in the 2020-21 financial year.

2.8 The Board has retained a reserve of £10,000.

2.9 Expenditure for the financial period was £37,751 and comprised of:

Balance

- 2.4 At the end of the financial year 2018/19 WH:UK had £80,164 in net assets.
- 2.5 The Trustees' reserve policy is to maintain a minimum balance of £10,000 with the aim of building it to £15,000. This was agreed by the Board on 14 April 2016. 2018-19 was the first year when it was not necessary to use the reserves at the end of the financial year which is encouraging.
