**Webinar: 'The Changing Nature of World
Heritage Designed Landscapes', 12th May**

Dr David Jacques was Inspector of Historic Parks and Gardens at English Heritage and at other times ran MA courses at the University of York and the Architectural Association on landscape conservation. As a consultant he was involved in the restorations of the Privy Garden at Hampton Court and the Elizabethan Garden at Kenilworth Castle.

Stephen Ratcliffe is Director of Sustainable Development for the Lake District National Park Authority (LDNPA); and was instrumental in the establishment of the Lake District National Park Partnership (LDNPP). He chairs the English Lake District World Heritage Site Steering Group and has overseen the development of the Partnership Plan (the statutory Management Plan for the LDNP and English Lake District WHS); a first for any National Park in the UK.

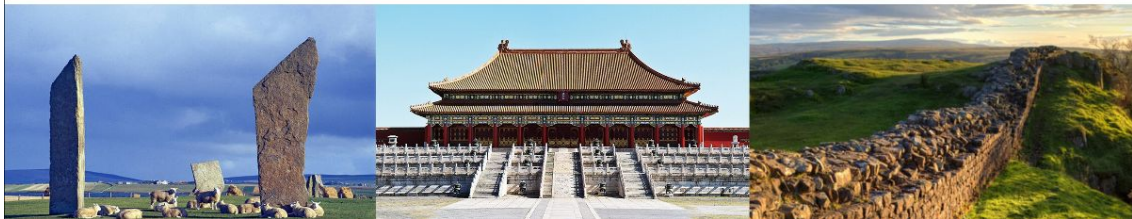
'World Heritage Day' 18th April 2021
